9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled City and County of San Francisco v.
12 Stantec Consulting Services Inc., et al., Alameda County Superior Court, Case No.
13 RG13679711, by the payment of \$14,000,000 to the City by defendants, and release of all
14 claims by defendants against the City for an unpaid contract balance of \$1,285,000. All
15 parties will execute a mutual release of current claims against one another, excluding a
16 release of defendants' liability for latent defects, and defendants' claims against various third
17 parties subject to defendants' obligation to defend, indemnify, and hold the City harmless for
18 future lawsuits arising from such claims.
