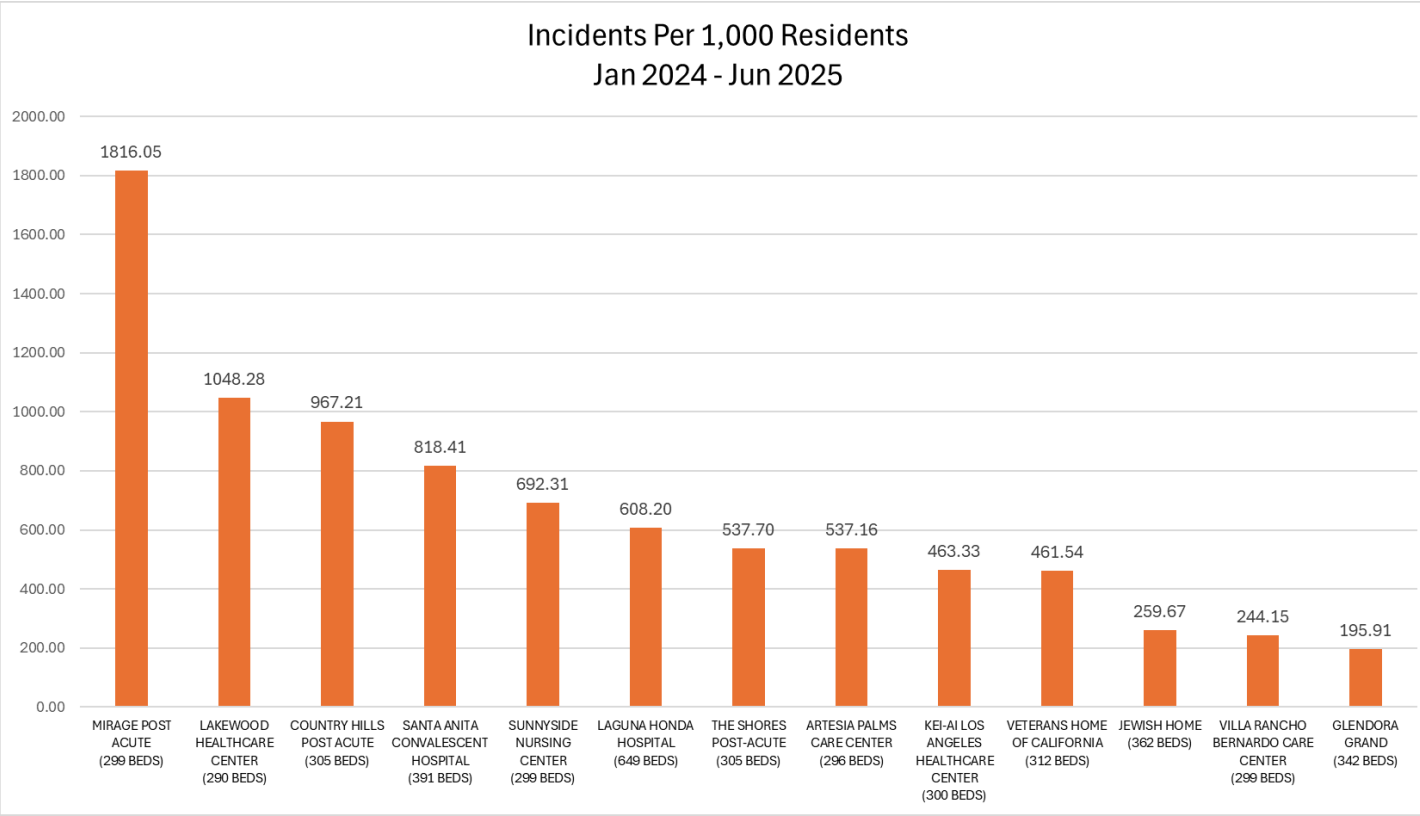
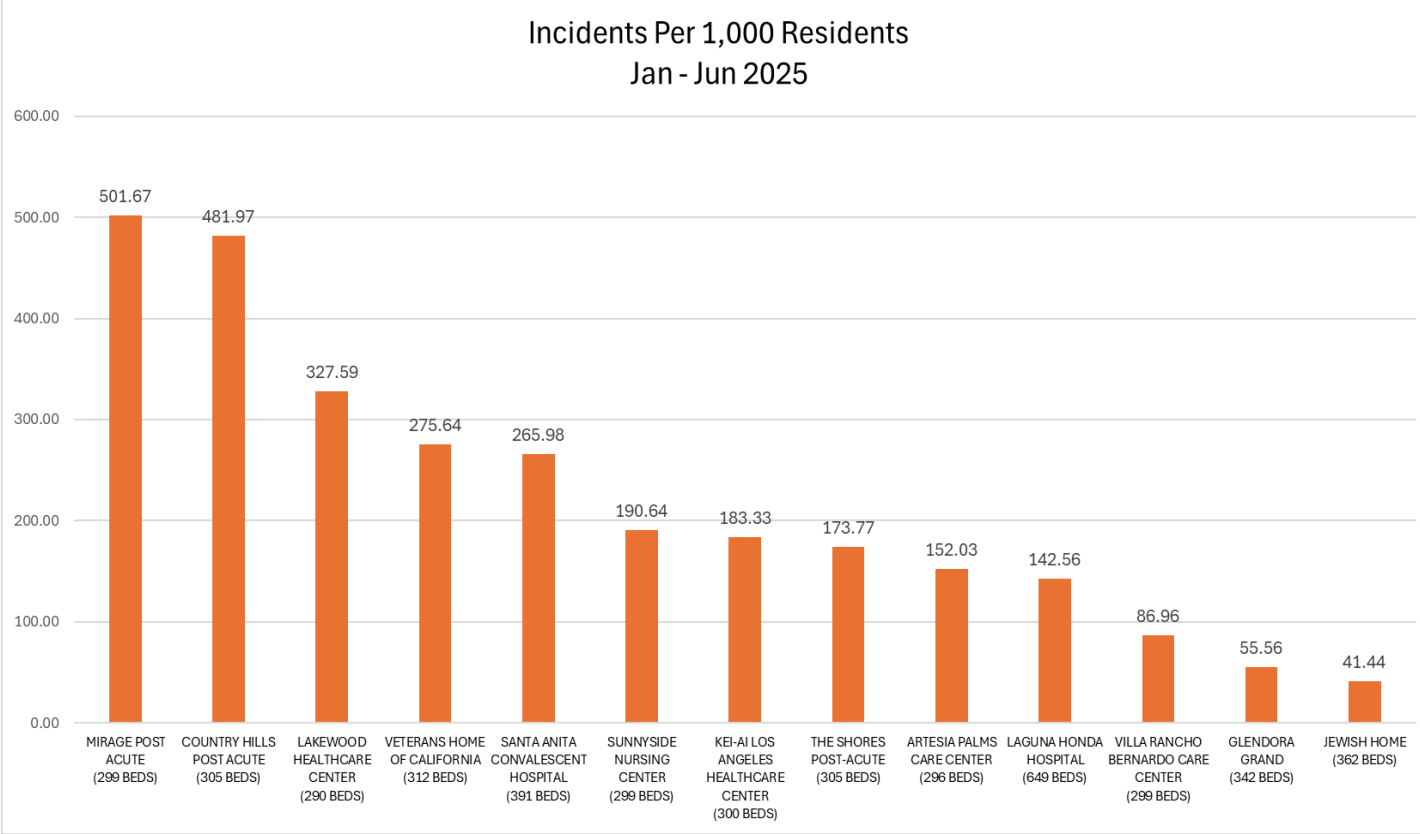

Between January 2024 through June 2025, LHH had an average census of 439 residents with a rate of 608.20 incidents per 1,000 residents – 66.5% lower than the highest reported rate (1816.05) of incidents per 1,000 incidents across all facilities.

Between January 2025 and June of 2025, LHH had an average census of 477 with a rate of 142.56 incidents per 1,000 residents – 71.5% lower than the highest reported rate (501.67) of incidents per 1,000 residents across all facilities

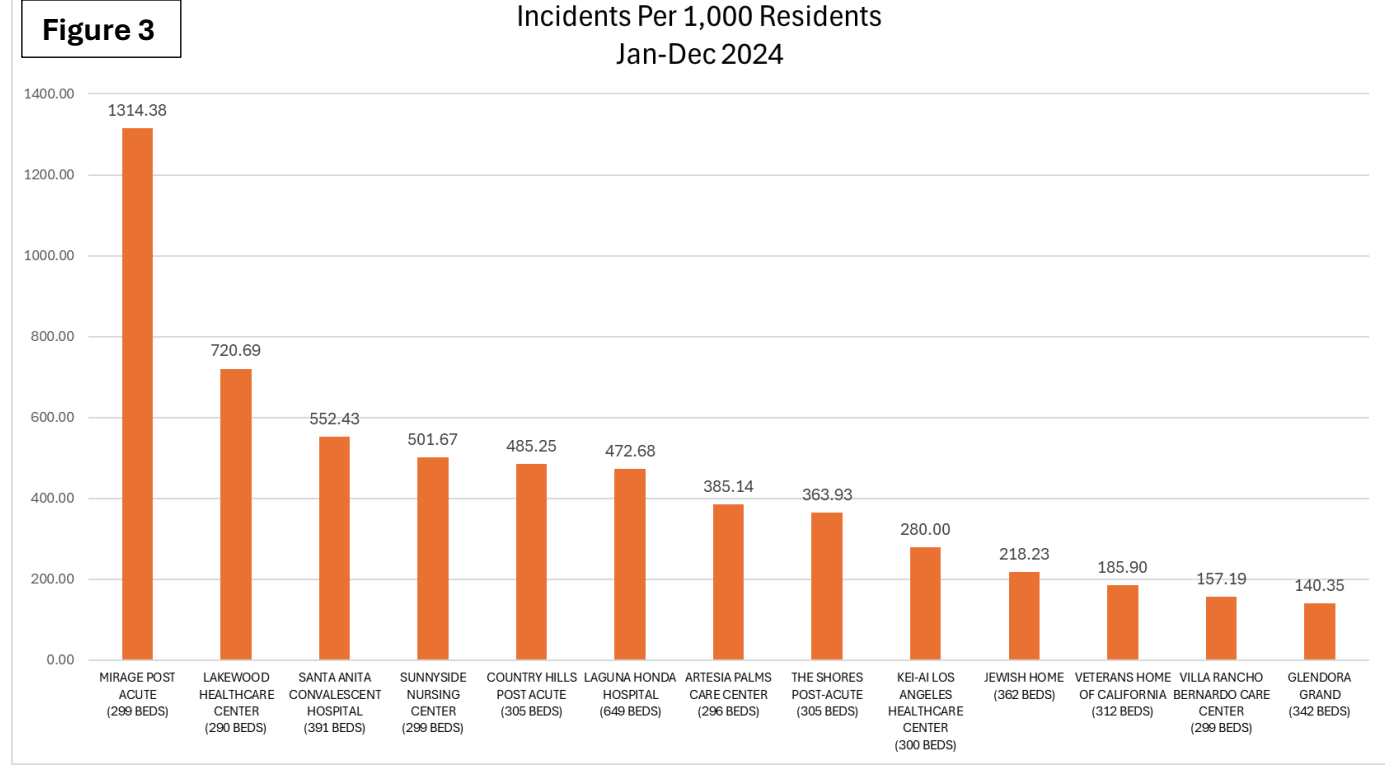

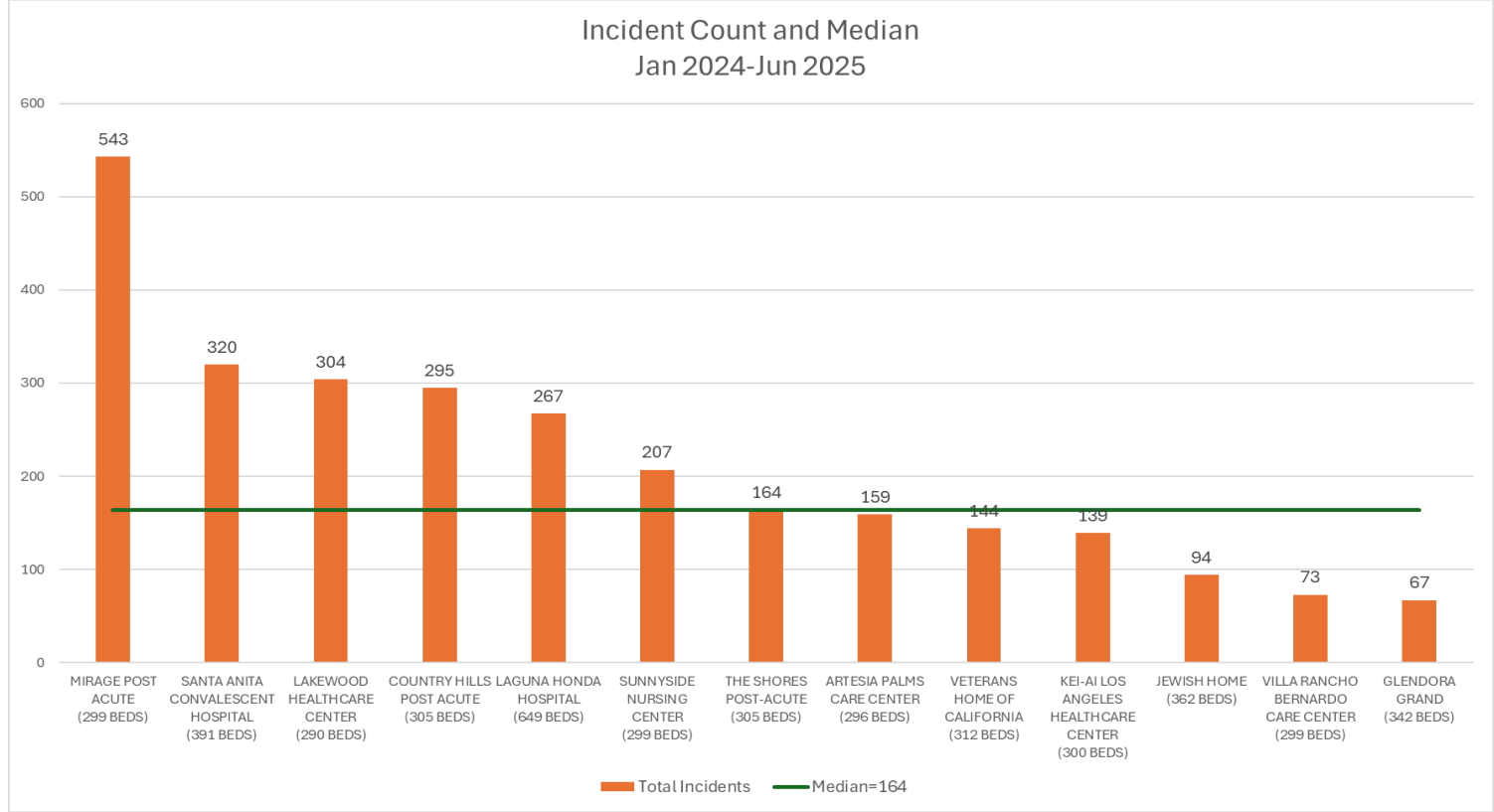
Between January 2024 and December of 2024, LHH had an average census of 421 with a rate of 472.68 incidents per 1,000 residents – 64% lower than the highest reported rate (1314.38) of incidents per 1,000 residents across all facilities.

Between January 2024 and June 2025, Laguna Honda Hospital (LHH) had a total of 267 incidents which is above the median of 164 however still below several other facilities which are much smaller size.

**Jan-Jun 2025**

Laguna Honda Hospital had 68 incidents and slightly above the median of 57. Overall, we have seen a decline compared to previous year.

**Jan-Dec 2024**

Laguna Honda Hospital had 199 incidents, and above the median of 114.

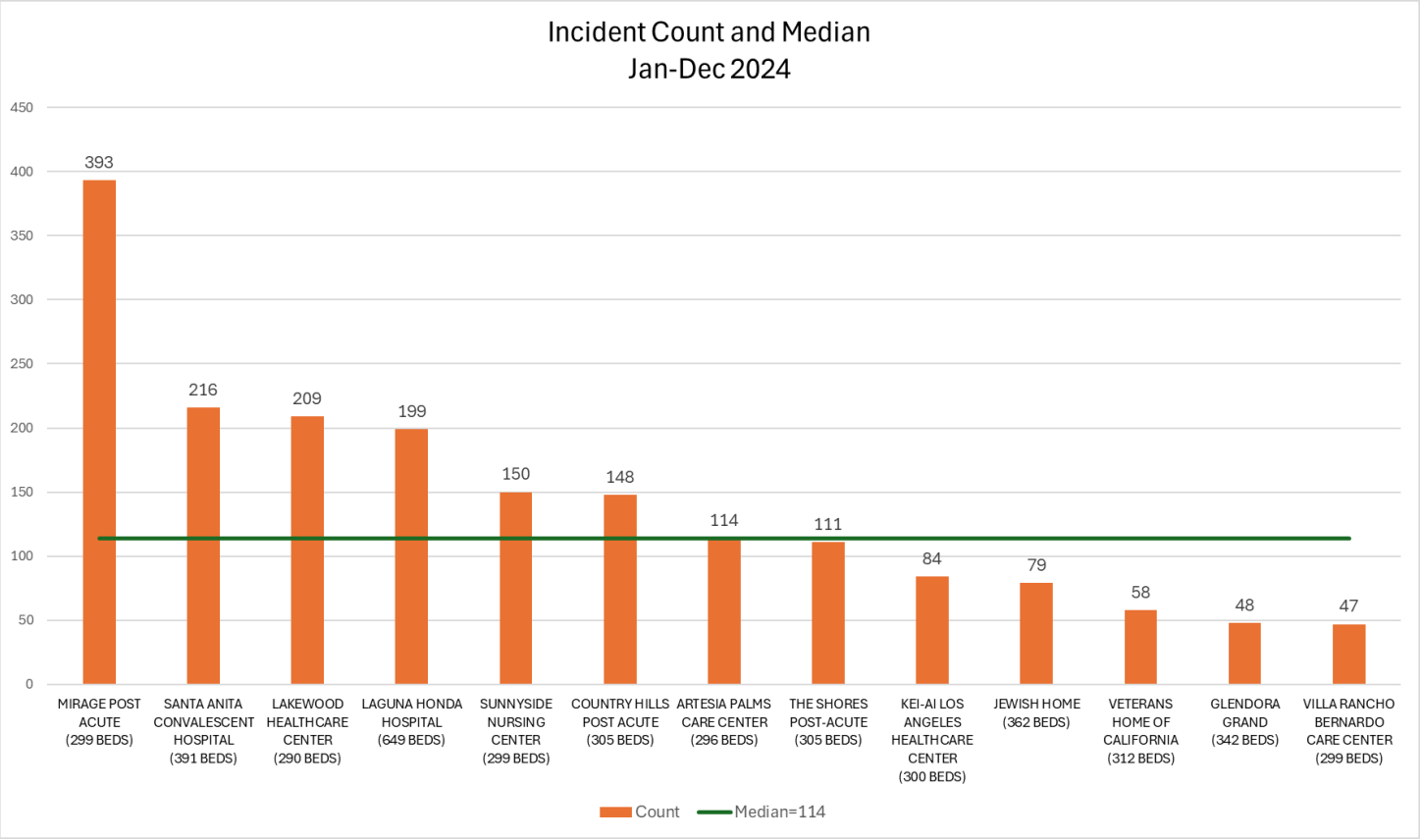
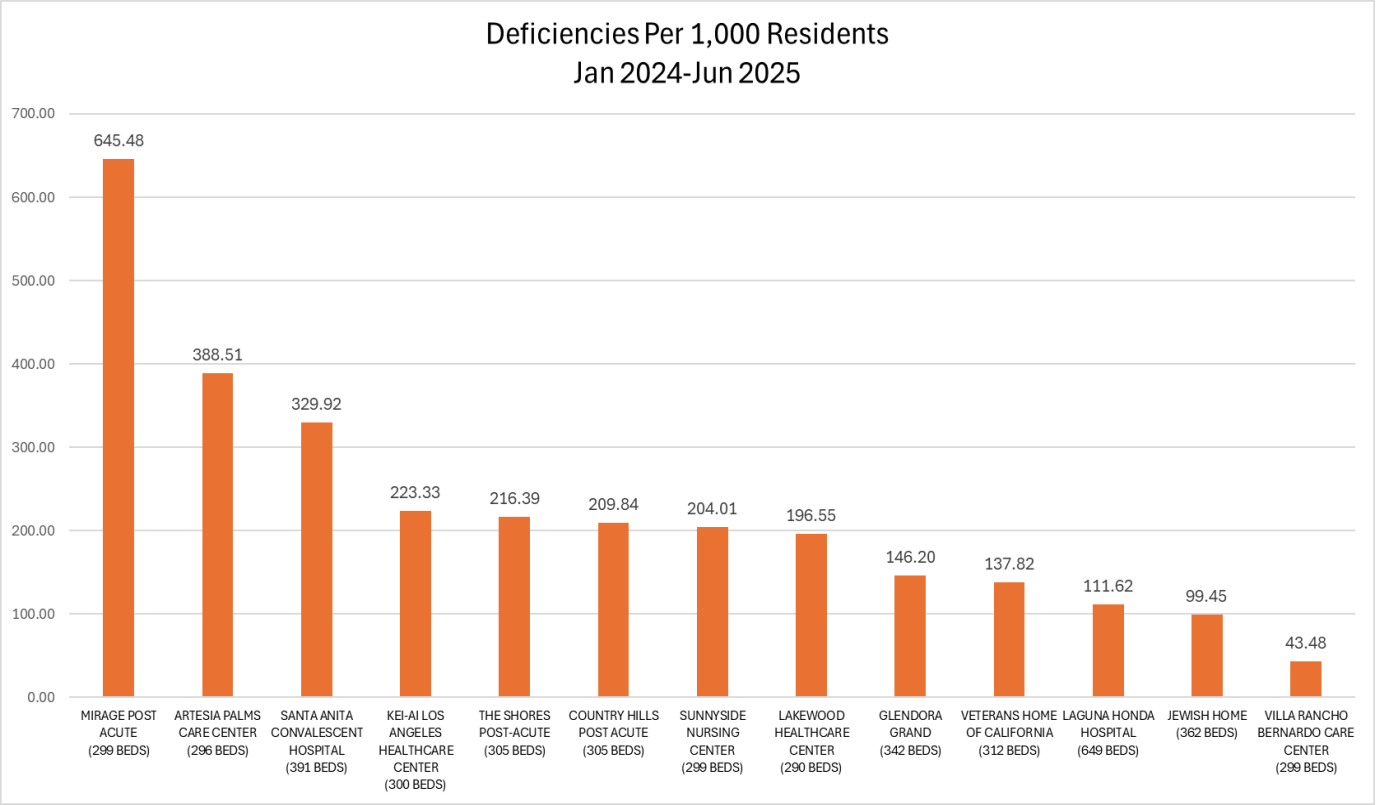

Between January 2024 and June 2025, LHH had an average resident census of 439 and a rate of 111.62 deficiencies per 1,000 residents – the third lowest rate of deficiency compared to all facilities and 82.7% lower than the highest rate (645.48) seen across the facilities.

Between January 2025 and June 2025, LHH had an average resident census of 477 and a rate of 41.93 deficiencies per 1,000 residents – 83.7% lower than the highest rate (257.53) seen across the facilities.

Between January 2024 through December 2024, LHH had an average resident census of 421 and a rate of 68.88 deficiencies per 1,000 residents – the second lowest rate of deficiency compared to all facilities and 82.2% lower than the highest rate (387.96) seen across the facilities.

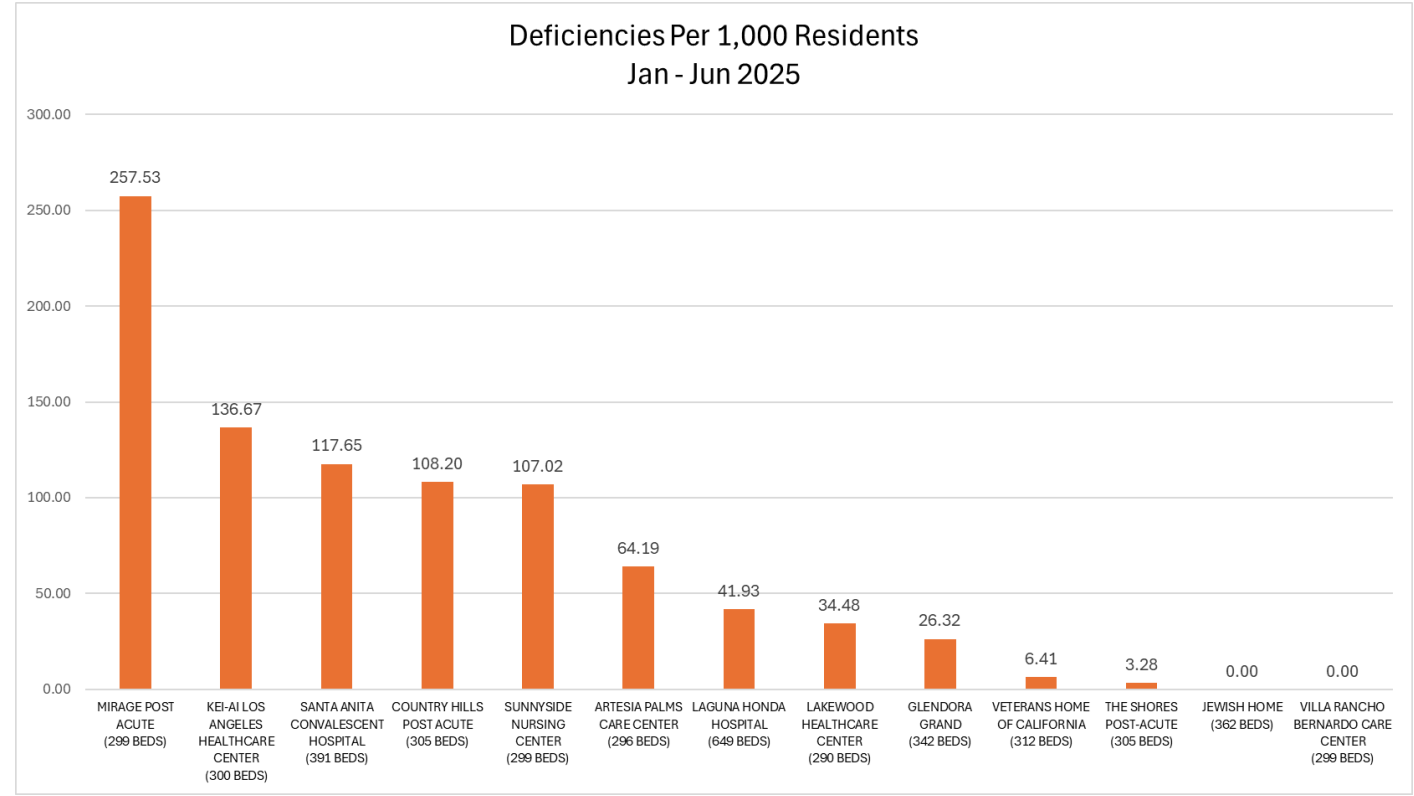

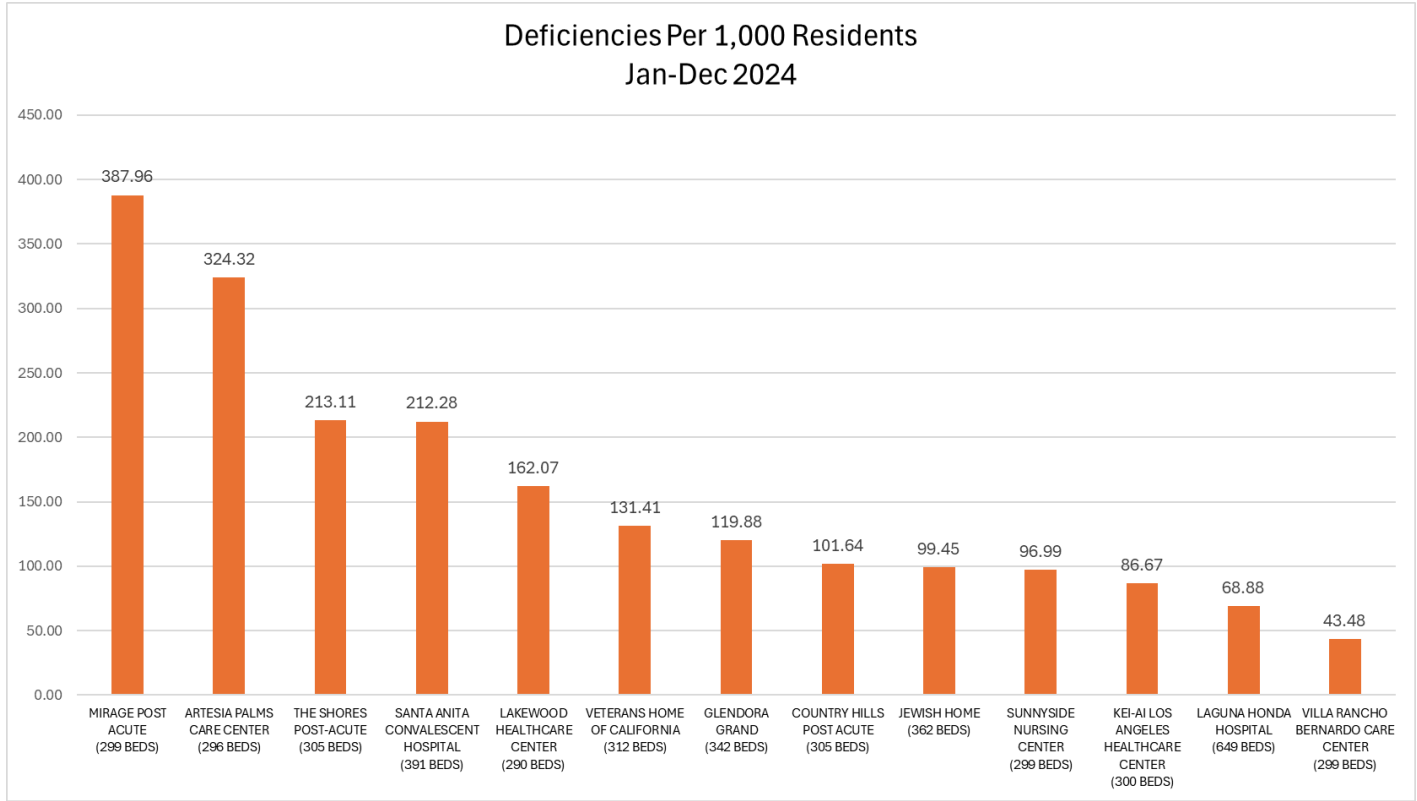
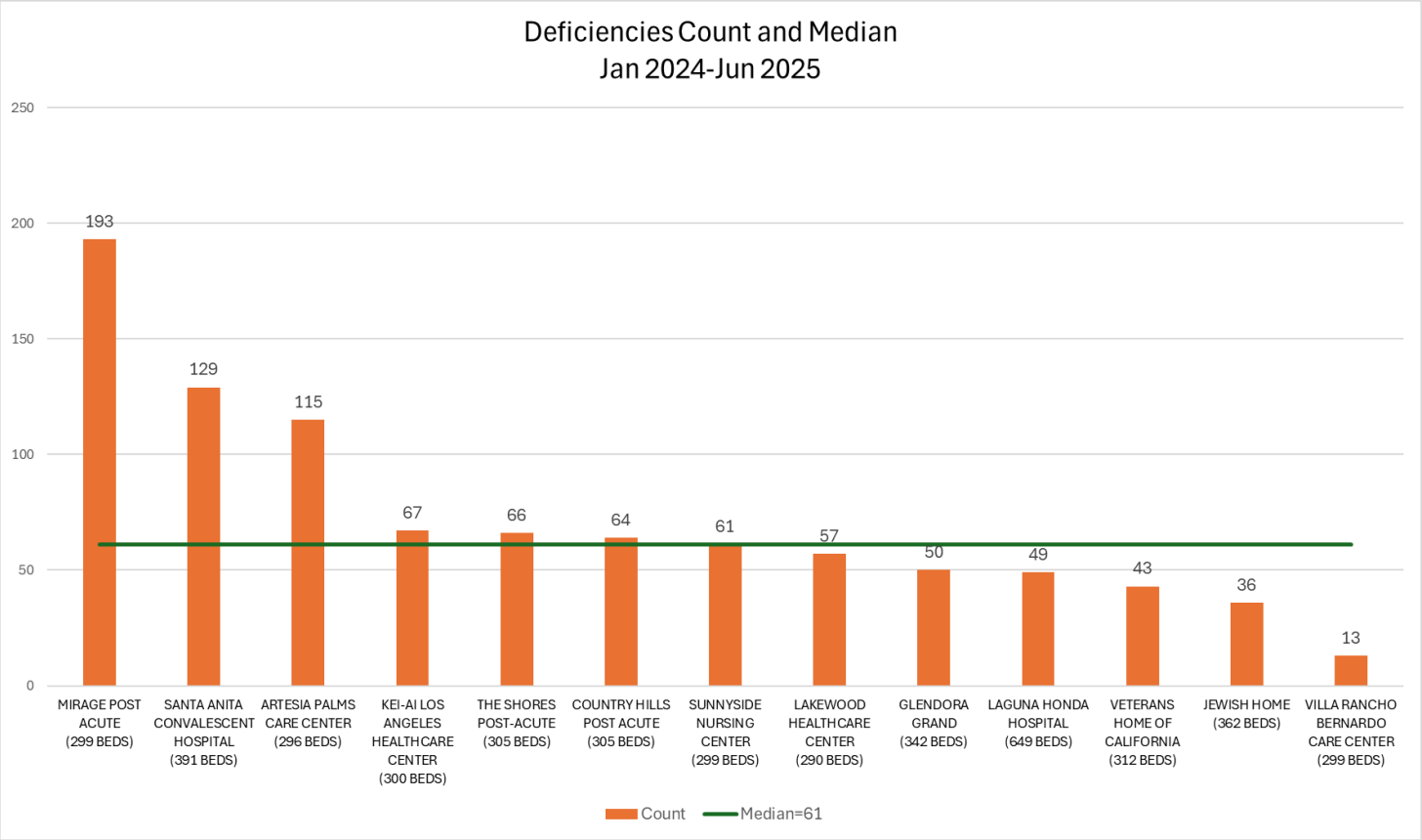

Between January 2024 and June 2025, Laguna Honda Hospital (LHH) had a total of 49 deficiencies – 20% lower than the median (61).

Between January 2025 and June 2025, LHH had 20 deficiencies – 1x higher than the median (20) and lower than 38% of the other facilities count.

**Jan-Dec 2024**

Between January 2024 through December 2024, LHH had 29 deficiencies – nearly 71% lower than the median (41).

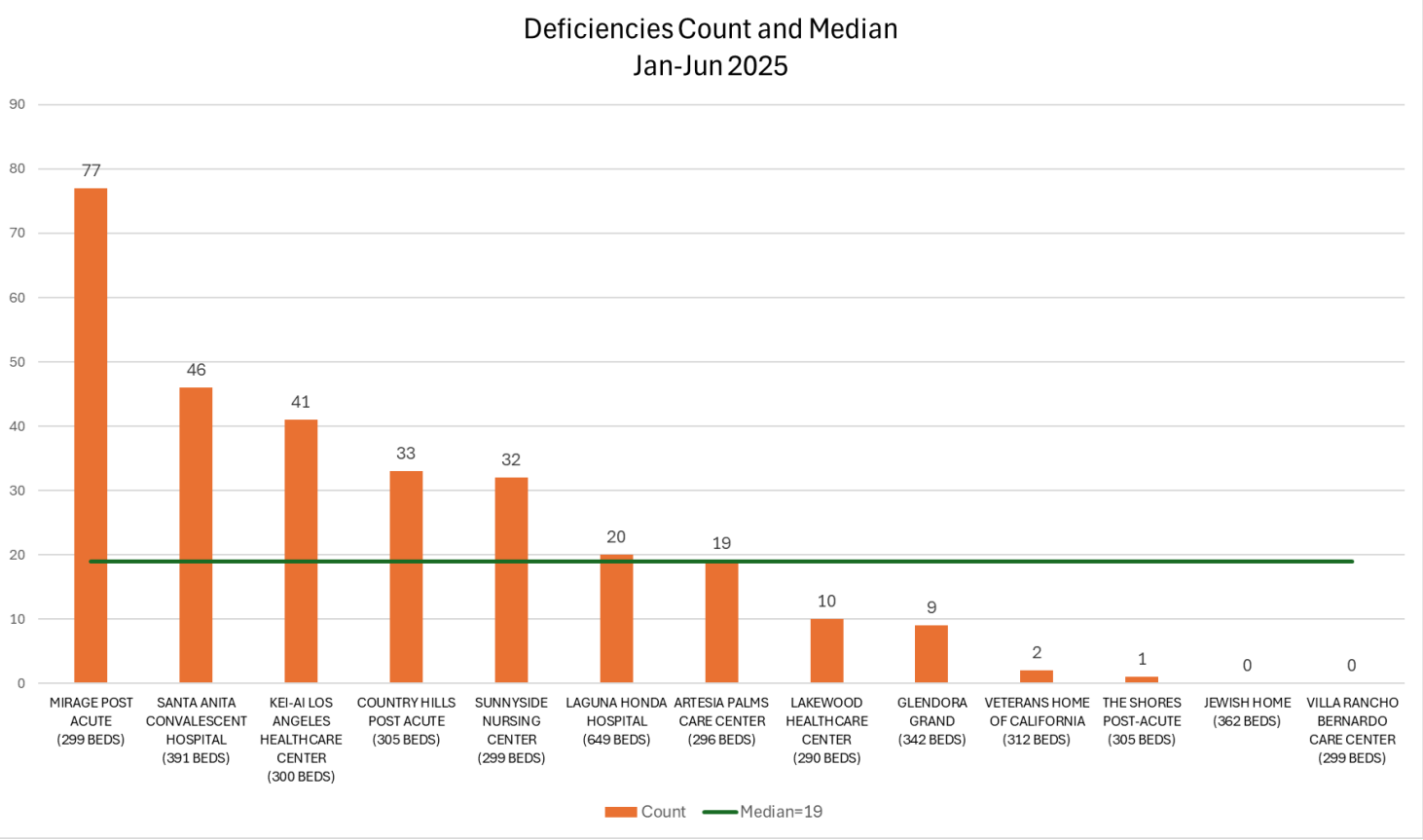
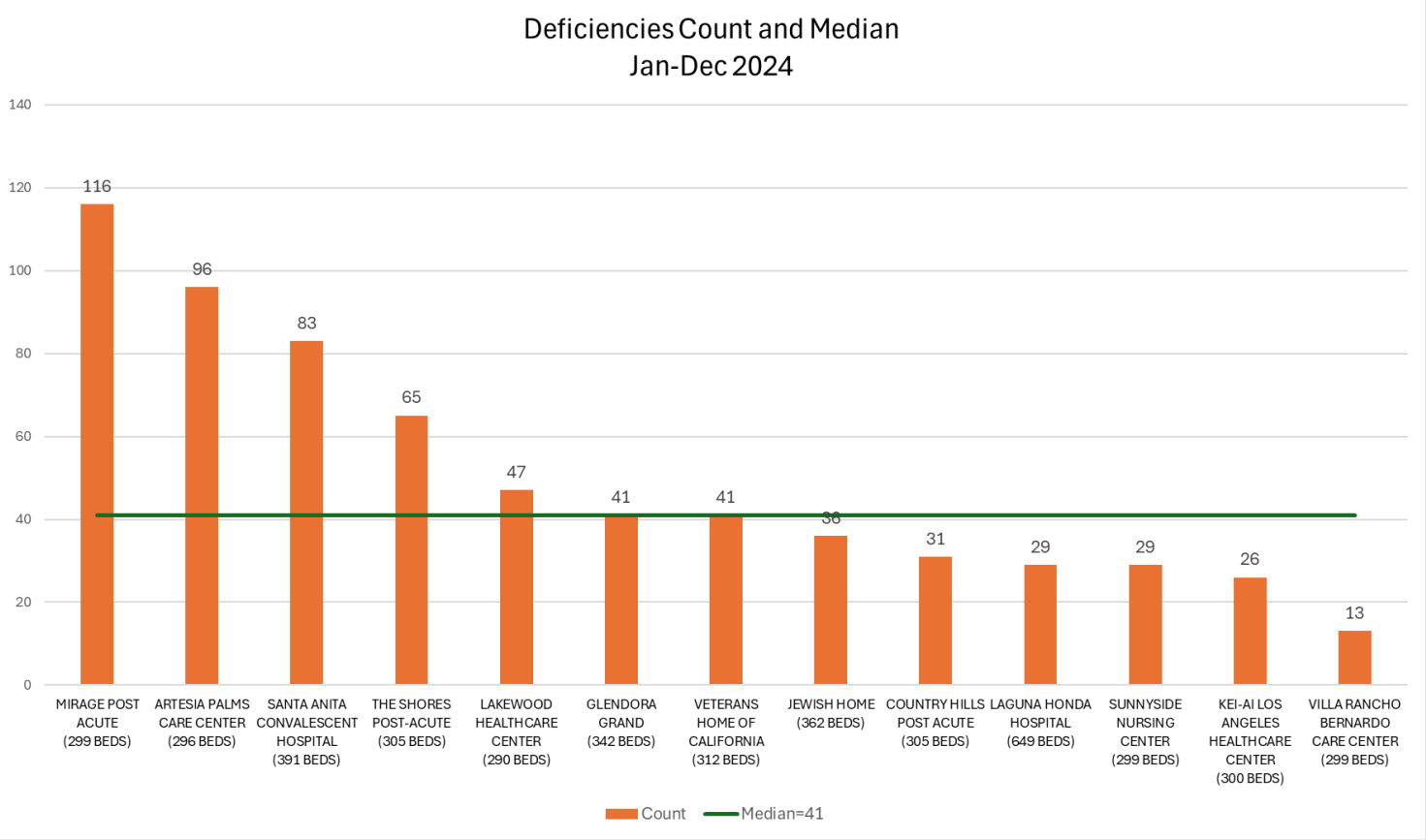
