Dear Mr. Lee,

This is an Immediate Disclosure Request for public records under San Francisco's Sunshine Ordinance, the California Public Records Act, Proposition 59, and the Brown Act.

Recommendation 4 in the 20132014 Civil Grand Jury's report "The Mayor's Office of Housing: Under Pressure and Challenged to Preserve Diversity," noted that when Housing Trust Funds (HTF) are allocated to Housing Authority properties and projects, MOHCD and the Mayor should document a funding analysis for the allocations in the year of encumbrance, with annual updates to an report on repayment of those funds back into the HTF.

MOHCD's September 5, 2014 consolidated response to the Grand Jury indicated MOHCD would provide a report regarding use of the HTF and other resources allocated to public housing at the end of the year of

encumbrance, and MOHCD would in such reports all relevant information regarding repayments.

Please provide:

1. Provide all such reports describing the use of HTF and other resources allocated to public housing, indicating clearly the year(s) of encumbrance, the amount encumbered, and the funding sources that have been issued since September 2014.
2. Include all data showing repayments to the HTF or other funding resources, and the fiscal year in which repayments were made.
